4. In the begining floral welcome was accorded to Sr. Vice President, Sh, Vishesh Sarangal, IAS by the Executive Committee.

The Agenda for the General Body Meeting was:-

a) Approval of the minutes of last AGM held on 28<sup>th</sup> Nov 2021.

Hony. Secretary read the minutes of the previous Annual General Meeting held on 28<sup>th</sup> Nov 2021 and the same were unanimously approved by the General House.

## b) To adopt accounts for the Financial Year 2020-2021 and 2021-2022.

The treasurer of the Club Sh. Gurpreet Singh Kochar presented Balance Sheets for the financial year 2020-2021 and 2021-2022 in the General House. He read out the major points of the Balance Sheets and the same were unanimously approved and passed by the General House without any objections.

- c) Any other matter with the permision of the chair.
- 1. Mr. Rakesh Jhanji, A/c No. 1076. he suggested that as per the norms of the club constitution the Balance Sheet must be presented in General House before filing the Income Tax Returns.



- Mr. S.P.S. Virk, A/c No. 2975, he raised issue of the repair and relairing of the 2. Synthetic Court and pointed out that the work done by the vendor is not satisfactory.
- (a) He further pointed out that there should be seperate kitchen for preparing vegetarian food.
- He further suggested that all the development projects must be passed in the Executive (b) Committee.
- Mr. Anil Nischal, A/c No. 3049, he suggested that the age limit for the transfer of 3. membership under "Uphaar Scheme" may be reduced from 70 to 60 years and the amount should be increased under the "Golden Hand Shake Scheme".
- 4. Mr. R.K. Gandhi, A/c No. 2540, he suggested that there should be a development Committee consisting of members of the club to look after the develoment projects going on in the club.
- Mr. Naresh Tiwari, A/c No. 2843, he suggested that since the number of club members is more than 4000, the number of Executive Members may be increased from 10 to 15 and one senior citizen member and one lady member may be co-opted in the Executive Committee.
- 6. Mr. Salil Gupta, A/c No. P338, he raised the isue of GST collected on the development charges from the members and suggested that management should consult with Club Chartered Accountant regarding the possibilty of the waiver of GST amount on the development charges.
